The Public Institution National Administration “Apele Moldovei” (“Waters of Moldova”), acting within the limits of its legal competences, has examined the request of the Danceni Village Mayor’s Office, No. 03 of 12 January 2026, concerning the issuance of an agreement in principle / letter of support for the participation of the Danceni Local Public Authority in the subproject “Recovery of Lake Danceni: feasibility, monitoring, demonstration and extension of an integrated Path4Med indicator solution”, submitted under the Path4Med Open Call for Financial Support to Third Parties (Horizon Europe), with an implementation period foreseen for July 2026 – March 2027.

Within the scope of its statutory mandate, the Public Institution National Administration “Apele Moldovei” hereby expresses support in principle, without assuming any financial, contractual, technical, or operational obligations, and exclusively on the condition that all activities are implemented strictly in the form, scope, objectives, and location described in the submitted request. This support in principle is granted conditionally and cumulatively, subject to compliance with the following mandatory requirements:

All activities shall be carried out in coordination with the Public Institution National Administration “Apele Moldovei”, including prior notification regarding the monitoring schedule and the exact sampling points;

All activities shall comply fully with the legislation in force of the Republic of Moldova in the fields of environmental protection, water management, protection of aquatic ecosystems, and the legal regime governing the use of water bodies;

Any activities involving physical interventions on hydrotechnical constructions, modifications of existing installations, or changes to the operating or exploitation regime of the lake shall be admissible only after the submission of appropriate technical documentation and the prior obtaining of all required permissive acts, in accordance with the applicable legal framework.

The present support in principle does not constitute an authorization, approval, consent, or permissive act, does not replace statutory procedures, and does not prejudice the outcome of any future administrative, technical, environmental, or permitting assessments.

Any subsequent actions or requests related to the implementation of the subproject shall be examined separately, on a case-by-case basis, strictly in accordance with the legislation in force.
